As the project applicant, Tampa Hillsborough Homeless Initiative's (THHI) CEO, Antoinette Hayes-Triplett, and COO, Antonio Byrd, have over 40 years of prior experience managing federal, state, and local grants. Currently, THHI’s annual budget is \$20 million. In addition, THHI's senior management staff has over 80 years of combined experience administering local, state, and federal programs for persons experiencing homelessness.

THHI is the lead entity for administering the county-wide response to make homelessness rare, brief and non-recurring in Tampa/Hillsborough County. THHI, formerly the Homeless Coalition of Hillsborough County, was created when the state of Florida called for all large communities to form a group to collaboratively address homelessness. The organization was incorporated in 2000 and began functioning as the leader for the Tampa/Hillsborough County community to become recognized as the CoC lead agency. THHI staff are knowledgeable with the populations experiencing homelessness in our community, what resources are available, what unmet needs are readily expressed, and the challenges of assisting sub-populations. THHI is responsible for development of the community's plan for making homelessness rare, brief and non-recurring and regularly meets with community stakeholders. Technical assistance is provided to assist organizations in their efforts to implement solutions and provide effective programs. Through partnerships with community organizations, THHI seeks new resources to support services and housing development. THHI has been the direct recipient of federally funds for CoC, HPRP, VHPD and SSVF. As the grantee, THHI monitors the projects regularly via data quality and APR reviews, review of eligibility documentation, detailed review of reimbursement requests, and desk and on-site monitoring activities.

THHI, as the lead entity/applicant, has received a proposal for the construction of The B.E.A.C.H. House. HUD funding is not needed for construction. THHI has not selected a sub-recipient for The B.E.A.C.H. House; it is the intent to select a service provider, via a RFP process.

2. Describe your organization’s (and subrecipient(s) if applicable) experience in leveraging Federal, State, local and private sector funds.

THHI, the applicant, has over 50 years of leveraging other Federal, State, local, and private sector funds. The management team has over 80 years of combined experience. Over the past year, THHI's CEO has leveraged over \$4 million in new funding from other sources. Over 80% of THHI's budget is leveraged from other sources.

THHI’s Finance Manager, Cathy James, has almost 30 years of experience as a for profit Corporate Controller before joining THHI 11 years ago. She holds a Master of Arts degree in accounting from The University of Alabama and a CPA Certificate from the State of Mississippi. Her areas of responsibility include all internal and external accounting and audit, grant administration, risk management, cash management, payroll, benefits and human resource filings.

The Finance Manager is required to comply with not only Generally Accepted Accounting Principles (GAAP) but also the U.S. Office of Management and Budget Circular A-133, Audits of States, Local Governments, and Non-Profit Organizations, and Chapter 10.650 Rules of the Auditor General, Florida. The organization has processed HUD Request Voucher for Grant Payment through both the phone LOCCS/VRS and internet eLOCCS systems and used the U.S. Department of Health & Human Services Division of Payment Management for SSVF payments. The accounting staff has assisted THHI Contract Managers in monitoring sub-grantees' financial administration when needed. As the lead agency in Hillsborough County, the accounting staff provides technical assistance to member agencies when needed.

1. Provide a description that addresses the entire scope of the proposed project.

In Tampa/Hillsborough County we have adopted two philosophies 1) housing is health care and 2) the only solution to homelessness is homes. However, for far too many of our residents experiencing chronic homelessness, accessing housing is impossible. These individuals barely have the capacity to communicate with service providers and medical personnel; they absolutely do not have the capacity to navigate the complicated housing market. One solution to addressing our philosophies is The BEACH House.

The Beginning of the End to Abolish Chronic Homelessness (BEACH) House is a new permanent supportive housing program aimed at addressing severe cases of chronic homelessness in Tampa/Hillsborough County. The BEACH House is critical to the community's strategic plan, 560 In 560 Strategic Plan on Homelessness. The goal of the 560 Plan is to provide housing opportunities for 560 people in 560 days by addressing some of the top causes of homelessness. The BEACH House is one of the 10 initiatives of the 560 In 560 Strategic Plan on Homelessness:

1. Hillsborough County Expungement Clinic
2. Second Chance/Re-Entry Job Fair
3. Hot Spot Mobile Outreach
4. Rapid Exit from Shelters
5. Speed Leasing
6. Operation: REVEILLE
7. Housing is Healthcare
8. C.A.S.H. Program
9. Shared Housing
10. The BEACH House

The BEACH House is designed to provide a friendly and safe living environment for those with severe disabilities, individuals that would never have the capacity to navigate accessing housing, to sign a lease or to even maintain their own living space.

Due to physical, behavioral or mental disabilities and experiencing chronic homelessness, these individuals are the most visible and the most vulnerable in our community. Based on the past 5 years of data, those experiencing chronic homelessness in Hillsborough County are considered the most vulnerable population and typically represent 27% of those experiencing homelessness.

In this application, THHI proposes to establish one of three houses. Each house would accommodate 15 severely disabled/chronically homeless people. Each person would have their independent bedroom and bathroom; there would be shared common areas. The BEACH House will include around the clock, long-term case management. The BEACH House would be designed similarly to Fisher Houses, located across the country, that provides accommodations for military veterans' families. This design also allows each person the opportunity to give and gain support from those residing at The BEACH House.

Residents of The BEACH House will receive assistance with applying for mainstream services and connected with a SOAR specialist also a licensed clinical social worker. Residents will also be connected to the Hillsborough County Health Care Plan to ensure that they are receiving the most appropriate health care services. When applicable, the residents will be connected to appropriate employment opportunities.

The B.E.A.C.H. House is permanent supportive housing. On any given night, The B.E.A.C.H. House will be a place to call home for 15 of the community's most vulnerable formerly chronically homeless persons. The B.E.A.C.H. House will be home to those that will never be able to thrive in traditional emergency shelters or rental housing. The participants may never be able to sign a lease or even their names in an effort to end their homelessness. The B.E.A.C.H. House will have very low-barriers to obtaining and remaining in permanent housing. The B.E.A.C.H. House will have around the clock professional staffing to ensure housing stability, as well as, wrap-around supportive services for the participants.

The 15 program participants will be selected for The B.E.A.C.H. House by a coordinated and integrated group of mainstream health providers, social services providers and law enforcement.
