Tampa/Hillsborough County Continuum of Care to Receive Nearly \$40 Million to Address Homelessness During the Pandemic

July 23, 2020 - Tampa Hillsborough Homeless Initiative (THHI) will administer \$39,772,860 of recurring and new funding from federal, state, county and city governments on behalf of the Tampa/Hillsborough County Continuum of Care (CoC). THHI will contract with community agencies to provide housing and services for individuals and families who are experiencing homelessness.

As a result of the recent 2020 Universal Request for Proposal (RFP) process, THHI's Board of Directors approved the allocation of funds in response to the 560 In 560 Strategic Plan on Homelessness and the COVID19 pandemic. Funds awarded reflects contract periods of 18 - 24 months. The funds will be disbursed for homeless prevention, homeless outreach, emergency shelter, rapid rehousing, permanent supportive housing, and administration/planning/special projects. However, there is still a need for landlords with available units and funding for personal care items, household supplies and furniture.

"The 560 In 560 Strategic Plan on Homelessness was developed in June 2019 and received seed money from the Hillsborough County Board of County Commissioners earlier this year. With additional funding to address homelessness during the pandemic, our goal has moved from providing housing for people in 560 days to providing housing for every unsheltered resident in our community", said Antoinette D. Hayes-Triplett, CEO of THHI.
